# **TEMPORARY SIGN PERMIT - 2025 UPDATE**

Supporting business recovery after the Franklin & Palisades Fires

The Malibu City Council has enacted **Urgency Ordinance No. 526 U** to support businesses impacted by the 2025 Palisades Fire. This ordinance temporarily relaxes sign permit regulations until **May 21, 2026**.

### **KEY PROVISIONS**

- Shopping Centers: Up to 6 temporary signs
- Other Businesses: Up to 2 temporary signs per parcel
- Size Limit: Each sign must be 16 sq ft or less
- Foundations: Must be temporary no permanent foundations
- Illumination: Not allowed (unless specifically authorized)
- Expiration: All temporary signs must be removed by May 31, 2026

### **PERMIT PROCESS**

- Apply for a Temporary Sign Permit (TSP)
- Requirements:
  - Uniform application
  - Design plans (location, size height, content)
  - \$48 fee
- The Community Development Director may impose conditions for safety and nuisance prevention

## **TEMPORARY SIGN PERMIT - 2025 UPDATE**

Supporting business recovery after the Franklin & Palisades Fires

The Malibu City Council has enacted **Urgency Ordinance No. 526 U** to support businesses impacted by the 2025 Palisades Fire. This ordinance temporarily relaxes sign permit regulations until **May 21, 2026**.

#### **KEY PROVISIONS**

- Shopping Centers: Up to 6 temporary signs
- Other Businesses: Up to 2 temporary signs per parcel
- Size Limit: Each sign must be 16 sq ft or less
- Foundations: Must be temporary no permanent foundations
- Illumination: Not allowed (unless specifically authorized)
- Expiration: All temporary signs must be removed by May 31, 2026

#### **PERMIT PROCESS**

- Apply for a Temporary Sign Permit (TSP)
- Requirements:
  - Uniform application
  - Design plans (location, size height, content)
  - \$48 fee
- The Community Development Director may impose conditions for safety and nuisance prevention

### STANDARD SIGN PERMIT REQUIREMENTS (BEFORE FIRE)

- Regulations under Malibu Municipal Code (MMC Chapter 17.52)
- **Varied limits**: Size and type depended on use (e.g., identification, real estate, special events)
- **Permanent standards**: Signs integrated into building design, strict rules on area, placement, and colors
- Special event signs: Up to 16 sq ft, only 30 days before and 7 days after an event
- **Grand opening signs**: Up to 20 sq ft banners, allowed for 30 days (balloons for first 4 days)
- Additional rules applied to gas stations, subdivisions, fast-food drive-thrus, etc.
- Typically required longer review and Planning Commission approval for some sign types
